Alston-Pleasants Post-Graduate Scholars Fund Trustee Appointed

Beginning in 2009, the Fund has provided scholarships to each of the three Alston-Pleasants Scholar graduate and professional studies applicants.

Miss Missouri, as she was known, had said that she wanted the Alston-Pleasants Scholars Fund to commemorate the memory of her grandfather, Willis "Congress" Alston, a late 18th and early 19th century state, regional and national political leader. The 50th anniversary of that Fund was celebrated in a Person Place Preservation Society program in Louisburg, NC on May 25, 2008.
