The Trustees continue to strive to develop Fund-sponsored undertakings to promote stronger connections among the entire Alston-Pleasants Community.

We have established the tradition of holding two meetings each year for the Alston-Pleasants
Community (a Spring Meeting that rotates in location among the three home Counties and a Fall Meeting each year in Chapel Hill to which current Scholars will be invited).

The 2011 Spring Meeting was held in Halifax County and the 2012 Spring Meeting was held in Franklin County. We plan to hold our Spring Meeting in 2013 in Warren County.

We were pleased to have Dan Thornton, the UNC Student Aid Office Associate Director - Merit Scholarships, join us for the Fall Meeting in Chapel Hill on September 21, 2012. It was a great opportunity for Dan to meet a number of current Scholars and Trustees for the first time. In the future, we plan to include other visitors whose experience with and support of merit scholarship programs would be of interest and benefit to our Community.

As you know, all recipients of the undergraduate Alston-Pleasants Scholarships are eligible for our postgraduate and professional studies scholarships. Please let us know at alstonpleasants@aol.com on or before December 21, 2012 about your spring 2013 term plans.

We will need to know the course of study, the institution, applicable accreditation and the amount of your tuition. If an award is made, you will need to send us a transcript grades report.

To date, the Fund has provided scholarships to each of the five Alston-Pleasants Scholar graduate and professional studies applicants. Four Scholars have completed their graduate and professional studies while Georgia Blair Stephenson continues to pursue a law degree.

While Fund assets are limited, we do try to provide meaningful financial assistance. If you would like to contribute to this undertaking, the Fund is an Internal Revenue Service recognized tax-exempt 501(c)(3) private foundation so that your gifts of cash or stock can be currently

deductible for income tax purposes.

#### WHERE ARE THEY NOW?

**Diane Sutton Kuehn** (UNC, '87) had committed to Carolina and was virtually on her way without knowing she had even been considered for an Alston-Pleasants scholarship —until she was notified that she had won it! Apparently someone had nominated her, possibly her high school guidance counselor, she surmises.

Her expectations of what undergraduate life would be like were, of course, radically revised. As the youngest of three girls (one of her sisters is a Morehead scholar), raised by their father on a 400-acre farm between Henderson and Louisburg, she wasn't sure she could earn or borrow enough money to stay in school long enough to get a degree. But the A-P took care of that problem.

Upon graduation, she worked for a number of companies until she started her own firm, VisionPoint Marketing in 2001. Eleven years later, she now presides over a growing Raleigh-based company that provides online marketing consulting services and expertise, with a well-defined niche in the sector of higher education. Among her clients, whom she really likes to refer to as "people," are the NC State MBA program, UNC Charlotte,

Campbell University and Boston College. She estimates that at least 80% of her work is with institutions of higher learning. Still, she intends to maintain some diversity in her clientele, if for no other reason than to "keep from getting stale," but also, one suspects, as a hedge against unforeseen changes in the marketplace and trends in higher education, an attitude that is central to the concept of "corporate strategy" but too often forgotten.

I asked her how education in business prepared her for this kind of career, technology expertise notwithstanding. At UNC, Diane was exposed to marketing for the first time via an outstanding faculty member. Since then, she knew she wanted to be in marketing but found sales in a marketing firm the only entry point available to her upon graduation. She said her education at UNC was a springboard to many career opportunities that built upon one another. Now as an entrepreneur, Diane invests quite a bit of time mentoring and helping students and budding entrepreneurs who are trying to build their own companies or simply move ahead in their career.

And I think that is why the community of Alston-Pleasants scholars is proud to have Diane as an exemplar of what we are all about and what that scholarship has enabled her to do with her education, career, and life.


